5 **JURISDICTION AND VENUE**

6 1. This adversary proceeding arises in and relates to the consolidated  
7 Chapter 7 case *In re Steven Oscherowitz, Susan Oscherowitz and Universal Merchants,*  
8 *Inc.*, which is now pending before the United States Bankruptcy Court for the Central  
9 District of California, Case No. LA 04-22926-BB (the "Bankruptcy Case").

10 2. This Court has jurisdiction over this adversary proceeding pursuant to  
11 28 U.S.C. §§ 157 and 1334.

12 3. Venue is proper in this district pursuant to 28 U.S.C. § 1409.

13 4. This adversary proceeding is a core proceeding under 28 U.S.C.  
14 § 157(b)(2)(A), (B), (E), (F), (H) and (O), and the Court can and should enter final  
15 judgment.

18 **THE PARTIES**

19 5. David L. Ray is the duly appointed and acting chapter 7 trustee of the  
20 consolidated bankruptcy estate ("Plaintiff" or "Trustee").

21 6. At all relevant times, Defendant Agudath Chasidei Spinka, Inc., a New  
22 York not-for-profit corporation, did business within this district, or filed a Proof of  
23 Claim in the Bankruptcy Case ("Defendant").

1 III.

2 GENERAL ALLEGATIONS

3 7. This Bankruptcy Case was commenced on June 10, 2004 (the "Petition  
4 Date"), when Steven Oscherowitz and Susan Oscherowitz (the "Oscherowitizes" or the  
5 "Debtors") filed a voluntary petition under chapter 7 of the United States Code. David  
6 L. Ray was thereafter appointed as the chapter 7 trustee.

7 8. On June 24, 2004, Mr. Oscherowitz caused to be filed in the United  
8 States Bankruptcy Court for the District of Delaware a voluntary petition under  
9 chapter 7 of the United States Bankruptcy Code for Universal Merchants, Inc.  
10 ("UMI"), a "Subchapter S" corporation wholly owned by the Oscherowitizes.

11 9. In September 2004, the Trustee successfully moved the United States  
12 Bankruptcy Court for the Central District of California to transfer venue of UMI  
13 bankruptcy case away from the United States Bankruptcy Court for the District of  
14 Delaware, now Bk. No. LA 04-31426-BB. David L. Ray was thereafter appointed as  
15 the chapter 7 trustee of the UMI bankruptcy estate.

16 10. By orders entered on May 8 2006, the Oscherowitz and UMI bankruptcy  
17 estates were substantively consolidated.

18 11. Mr. Oscherowitz has listed, on the Schedule of Financial Affairs filed in  
19 this Bankruptcy Case, eighteen (18) business entities that he wholly or partially  
20 owned.

21 12. The Trustee's investigation reveals that, for many years pre-petition,  
22 Mr. Oscherowitz commingled his personal and business finances, including those of  
23 UMI. Mr. Oscherowitz transferred substantial amounts of funds both to and from  
24 these entities and, in many instances, credited and charged personal expenses to  
25 advance accounts.

1 **FIRST CLAIM FOR RELIEF**

2 **(For Avoidance and Recovery of Actual Fraudulent**  
3 **Transfer Pursuant to 11 U.S.C. §§ 544(b) and 550**  
4 **and California Civil Code §§ 3439.04(a)(1) and 3439.09**  
5 **and Other Applicable State Statutes)**  
6

7 13. Plaintiff incorporates herein by this reference the allegations in  
8 paragraphs 1 - 12.

9 14. Plaintiff is informed and believes and on that basis alleges that between  
10 June 11, 2000 to June 10, 2004, the Debtors transferred an interest of the Debtors in  
11 property by transferring no less than \$15,000.00 (the "Four Year Transfer") to the  
12 Defendant.

13 15. Plaintiff is informed and believes and on that basis alleges that the  
14 Four Year Transfer was made to Defendant within the four-year period immediately  
15 preceding the Petition Date and that the Four Year Transfer was of the Debtors'  
16 property.

17 16. Plaintiff is informed and believes and based thereon alleges the  
18 Transfers are avoidable by a creditor, which rights Plaintiff succeeded under 11 U.S.C.  
19 § 544.

20 17. Plaintiff is informed and believes and on that basis alleges that the  
21 Four Year Transfer was made to Defendant with the actual intent to hinder, delay, or  
22 defraud an entity or entities to which the Debtors were or became indebted, on or after  
23 the date that the Four Year Transfer was made.

24 18. Pursuant to 11 U.S.C. § 544(b) and California Civil Code  
25 §§ 3439.04(a)(1) and 3439.09, Plaintiff is entitled to avoid the Four Year Transfer to  
26 Defendant.

27 19. Plaintiff is informed and believes and on that basis alleges that Defendant  
28 is the initial transferee and/or for whose benefit the Four Year Transfer was made.



1 (b) intended to incur, or believed or reasonably should have believed  
2 that they would incur, debts beyond their ability to pay as they became due; or

3 (c) were insolvent or became insolvent as a result of the Four Year  
4 Transfer.

5 26. Pursuant to 11 U.S.C. § 544(b) and California Civil Code  
6 §§ 3439.04(b)(2), 3439.05 and 3439.09, Plaintiff is entitled to avoid the Four Year  
7 Transfer to Defendant.

8 27. Plaintiff is informed and believes and on that basis alleges that  
9 Defendant is the initial transferee and/or for whose benefit the Four Year Transfer  
10 was made.

11 28. Pursuant to 11 U.S.C. §§ 550(a)(1) or (2), Plaintiff is entitled to recover  
12 from Defendant the property transferred or the value of it, in an amount to be  
13 established according to proof at trial.

14  
15 WHEREFORE, Plaintiff prays for judgment as follows:

16 1. On the First Claim for Relief:

17 (a) That the Four Year Transfer made to Defendant be avoided  
18 pursuant to 11 U.S.C. §§ 544(b) and 550, California Civil Code §§ 3439.04(a)(1) and  
19 3439.09 and other applicable state statutes; and

20 (b) That the Four Year Transfer be preserved for the benefit of the  
21 Debtors' estates pursuant to 11 U.S.C. § 551.

22 2. On the Second Claim for Relief:

23 (a) That the Four Year Transfer made to Defendant be avoided  
24 pursuant to 11 U.S.C. §§ 544(b) and 550, California Civil Code §§ 3439.04(a)(2),  
25 3439.05 and 3439.09 and other applicable state statutes; and

26 (b) That the Four Year Transfer be preserved for the benefit of the  
27 Debtors' estates pursuant to 11 U.S.C. § 551.

## ADVERSARY PROCEEDING COVER SHEET (Reverse Side)

---

This cover sheet must be completed by the plaintiff's attorney (or by the plaintiff if the plaintiff is not represented by an attorney) and submitted to the Clerk of the Court upon the filing of a complaint initiating an adversary proceeding.

The cover sheet and the information contained on it **do not** replace or supplement the filing and service of pleadings or other papers as required by law, the Bankruptcy Rules, or the local rules of court. This form is required for the use of the Clerk of the Court to initiate the docket sheet and to prepare necessary indices and statistical records. A separate cover sheet must be submitted to the Clerk of the Court for each complaint filed. The form is largely self-explanatory.

**Parties.** The names of the parties to the adversary proceeding **exactly** as they appear on the complaint. Give the names and addresses of the attorneys if known. Following the heading "Party," check the appropriate box indicating whether the United States is a party named in the complaint.

**Cause of Action.** Give a brief description of the cause of action including all federal statutes involved. For example, "Complaint seeking damages for failure to disclose information, Consumer Credit Protection Act, 15 U.S.C. § 1601 et seq.," or "Complaint by trustee to avoid a transfer of property by the debtor, 11 U.S.C. § 544."

**Nature of Suit.** Place an "X" in the appropriate box. Only one box should be checked. If the cause fits more than one category of suit, select the most definitive.

**Origin of Proceedings.** Check the appropriate box to indicate the origin of the case:

1. Original Proceeding.
2. Removed from a State or District Court.
4. Reinstated or Reopened.
5. Transferred from Another Bankruptcy Court.

**Demand.** On the next line, state the dollar amount demanded in the complaint in thousands of dollars. For \$1,000, enter "1," for \$10,000, enter "10," for \$100,000, enter "100," if \$1,000,000, enter "1000." If \$10,000,000 or more, enter "9999." If the amount is less than \$1,000, enter "0001." If no monetary demand is made, enter "XXXX." If the plaintiff is seeking non-monetary relief, state the relief sought, such as injunction or foreclosure of a mortgage.

**Bankruptcy Case In Which This Adversary Proceeding Arises.** Enter the name of the debtor and the docket number of the bankruptcy case from which the proceeding now being filed arose. Beneath, enter the district and divisional office where the case was filed and the name of the presiding judge.

**Related Adversary Proceedings.** State the names of the parties and six-digit adversary proceeding number from any adversary proceeding concerning the same two parties or the same property currently pending in any bankruptcy court. On the next line, enter the district where the related case is pending and the name of the presiding judge.

**Filing Fee.** Check one box. The fee must be paid upon filing unless the plaintiff meets one of the following exceptions. The fee is not required if the plaintiff is the United States government or the debtor. If the plaintiff is the trustee or a debtor in possession and there are no liquid funds in the estate, the filing fee may be deferred until there are funds in the estate. (In the event no funds are ever recovered for the estate, there will be no fee.) There is no fee for adding a party after the adversary proceeding has been commenced.

**Signature.** This cover sheet must be signed by the attorney of record in the box on the right of the last line of the form. If the plaintiff is represented by a law firm, a member of the firm must sign. If the plaintiff is *pro se*, that is, not represented by an attorney, the plaintiff must sign.

The name of the signatory must be printed in the box to the left of the signature. The date of the signing must be indicated in the box on the far left of the last line.
